DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Andersontown Store is located on the south side of the intersection of Hignutt Road and Maryland Route 404 in Andersontown, Caroline County. The building is a late nineteenth century commercial structure that is presently an antique shop.

The store is a two story, rectangular shaped, three by three bay structure of frame and clapboard construction. The main facade (north elevation) has a double door central entrance with a 6/6 pane sash window to each side. The windows have paneled shutters and both the windows and the door frame have a molded flat shelf lintel. There is a full length, one story porch which continues across the front of a one story frame addition on the west side of the structure. This addition has a large 6/6 pane sash window on its north elevation and three windows along its west elevation. The west elevation of the main section also has three windows, as do both storys of the east elevation.

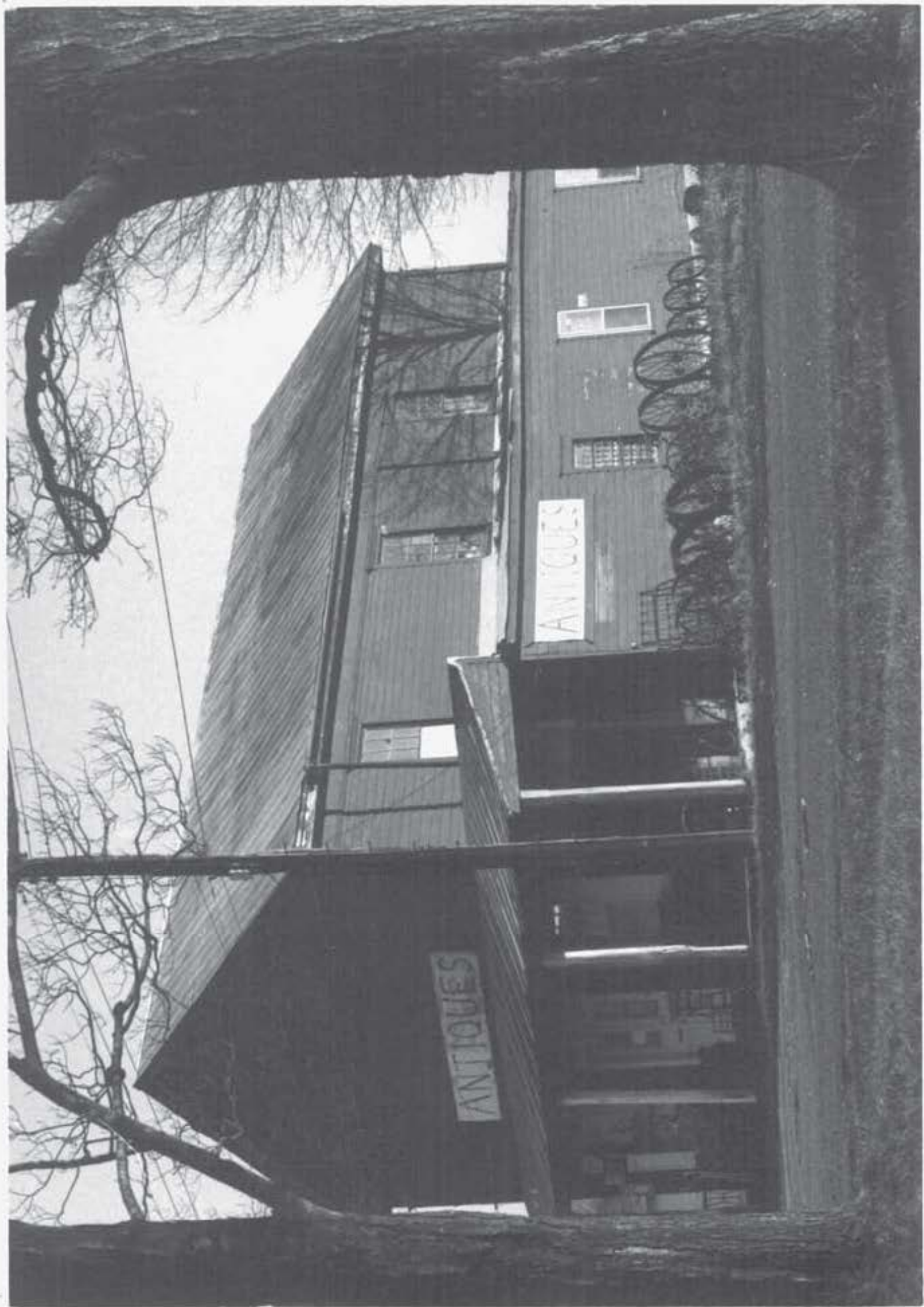

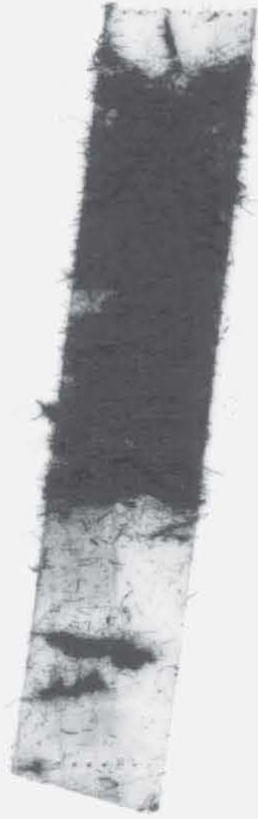
