DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Smallwood's Retreat is an extensively restored (only the foundations and parts of the exterior walls are original), one-story, gable-roofed, brick structure dating from the mid-Eighteenth Century.

The building sits on a high stone foundation punctuated by two basement windows with segmental arched timber surrounds on the front west and rear east facades, above a double molded water table, the brick of all four walls is laid in glazed flemish bond.

The main facade is four bays with the doorway located in the second bay from the southwest corner. A segmental arched wooden surround distinguishes this entrance. Simple timber surrounds frame the three 9/9 double-hung sash windows.

The four-bay, rear facade has two entrances, in the first and third bays, respectively, from the south corner. Doorway and window details are identical to those of the front facade.

The wood shingled roof is distinguished by three pedimented dormers on both planes. Windows are 9/9 double-hung sash.¹ A wooden cornice with modillions and blank frieze runs below the slightly kicked eaves, rake boards and corbeled internal chimneys distinguishes both gable ends.

To the south of the building is a detached, reconstructed one-story kitchen of molded edged clapboard. Nearby are the restored smokehouse and pumphouse.

An 1898 granite monument marking the site of Smallwood's grave lies to the southwest of the main house.

¹These dormers, however, are not found in various pre-1958 photographs which exist for the building. The earliest of these pictures, located in a commemorative pamphlet of 1898, depicts the west facade of the Retreat as displaying only a centrally placed dormer with 9/6 sash windows. A circa 1934 photograph appearing in Forman's Early Manor and Plantation Houses of Maryland, portrays the structure little more than a dilapidated brick shell. The picture does show the remains of a sole centrally positioned dormer. Neither photograph indicates the presence of flanking dormers. In 1940 the Historic American Buildings Survey documented what little remained of the Retreat. Their reconstruction drawings also illustrate a single dormer rather than a trio on the west facade. The east facade, unlike the present restoration, **CONTINUE ON SEPARATE SHEET IF NECESSARY** does not show the existence of dormers.

STATEMENT OF SIGNIFICANCE

Smallwood's Retreat holds a two-fold importance. Architecturally, the restored manor house represents an insight into the preservation/restoration techniques of the 1950s. More importantly, however, is its historical associations with Major General William Smallwood.

"When the names of Caesar, Alexander, Hannibal, Napoleon, Wellington shall have been forgotten, Washington, Franklin, Jefferson, Adams, Hancock and Smallwood will be incentives for all that is good and true and noble . . ."

Although Dr. Albert Kimberly Hadel perhaps exaggerated the eternal fame of the man, Major General William Smallwood nevertheless was a distinguished military leader and Maryland statesman.

The son of a wealthy Charles County planter, Bayne Smallwood, William reputedly spent his early years in England, receiving his formal education. He returned to America by the mid-1750s to assist his father at the family plantation, Mattawoman. In 1760 Charles was given land by his father and presumably this is when he built the Retreat.

Like his father, William became active in Charles County politics, serving the Lower House of the General Assembly from 1761-1774. Early in his career, he became disturbed by British imperial policies towards the colonies. In June 1774 at a Port Tobacco meeting, Smallwood joined his fellow countymen in supporting a resolution that would prohibit the importation of British goods into the county. Those present also favored the breaking of all relations with Great Britain. In a January 1775 meeting at Port Tobacco, William Smallwood was one of thirteen men appointed to represent the county in the next provincial convention at Annapolis.

When war with Great Britain finally erupted, Smallwood immediately enlisted for active military duty. As colonel of the 1st Maryland Regiment, he joined his friend, General Washington, in New York. Participating in the Battles of Long Island and Harlem Heights, Smallwood and his troops were responsible for covering Washington's retreat. At the Battle of White Plains in August 1776, again protecting Washington's army, Smallwood was wounded. For his bravery in these

battles he was promoted to brigadier general. He also participated in the Battles of Fort Washington, Trenton and Princeton. At Germantown, in October 1777, his Maryland line captured part of a British camp. In 1779-1780 Smallwood's troops were stationed at Wilmington, Delaware, where they protected Washington's stores near Elk Neck. Soon after, he and his men marched to South Carolina to fight the Battle of Camden. Because of these military successes, he received the commission of major general as well as a note of thanks from Congress.

Smallwood's exaggerated pro-American sentiment and offensive attitude toward foreigners alienated himself from many of his military peers. After the Battle of Camden and his promotion, Smallwood was placed under the immediate command of General Baron von Steuben. Although the major general protested, threatening to resign from the military rather than to serve under a foreign officer, both Washington and Congress would not yield to his demands. To ease the tension, General Nathaniel Greene ordered Smallwood to return to Maryland to raise supplies and recruit reinforcements. Despite these problems, Smallwood remained in military service until November 1783.

Shortly thereafter Smallwood was elected to Congress, but before he would assume his duties, the legislature appointed him governor to succeed William Paca. During his three terms in office, Smallwood was remembered for two important contributions to his state. He called the Maryland Convention which ratified the U.S. Constitution. Thus Maryland became one of the first nine states to pledge itself to a federal system of government. Secondly, a compact was signed in 1785 between Maryland and Virginia on their mutual boundary, the Potomac River. This agreement essentially gave Maryland the jurisdiction over the waterway and securing fishing and oystering rights on both sides of the river.

At the end of his gubernatorial services, Smallwood returned to his Charles County plantation. The U.S. Census of 1790 lists William Smallwood owning 56 slaves. According to records of the Durham Parish, he had a yearly crop of tobacco of 3,000 pounds. In the fall of 1791, Smallwood was elected to the State Senate and chosen President for that session. He died the following February (1792) before completing his term in office.

In addition to his political concerns, Smallwood was a member of the vestry of Old Durham Church. Church records indicated that he re-roofed the structure at his own expense as well as building a road from his Retreat to the church. Smallwood, like his close friend, George Washington, was active in the Alexandria Lodge of Masons. It is believed that George Washington, along with fellow masons frequently met at Smallwood's Retreat.

The restoration of Smallwood's Retreat is due to the persistent and successful efforts of Smallwood Foundation, Incorporated, who in 1939 purchased ten acres of land including the manor house, and the burial plot.² Although preliminary plans were drawn up in the early 1940s to excavate and restore the structure, it was not until 1954, however, through a Senate Resolution, that the governor was "requested to place in the supplementary budget a sum sufficient to restore the old manor house and the neglected grave at the ancient house of Major General William Smallwood in Charles County".³ When these state appropriations were received, final plans were executed by Colonel C.P. Sanvston, an architect with the Maryland Department of Public Improvement, and H.P. Hopkins, a Baltimore restoration architect, Colonel Walter Simpson, an engineer, volunteered to supervise the restoration construction.

Upon completion of the project, the Foundation deeded the 10-acre parcel to the State of Maryland, Department of Natural Resources, with the understanding that additional land would be acquired for the development of a state park. Smallwood's Retreat was dedicated by Governor Theodore McKeldin and open to the public September 19, 1958.

Smallwood Foundation, Incorporated, still acts as an advisory board to the park and has been instrumental in acquiring period furniture and other colonial household items to furnish the interior of the Retreat.

Smallwood's Retreat is a one and a half story brick house which the State and the Smallwood Foundation, Inc., has restored using the original foundation and the parts of the walls still intact. It sits on a stone foundation. The basement windows are trimmed with brick and have segmental arches. There is a double, molded water table. The basement entrance has a segmental arch and the water table jogs above the entrance; it is located on the north east gable. Above the water table the brick is laid in Flemish bond with glazed headers. It is four bays wide. The door is in the second bay from the west corner. There is a segmental arch over the door but the windows have no arches. The wood cornice has modillions and end-boards. There are three "A" roof dormers in the roof which have nine over nine sash, as do the windows at the first floor level. There is a slight kick to the eaves. The rear of the building has two doors in the first and third bays respectively, from the south corner. The chimneys are entirely within the building. To the south of the building is a three-bay one-story reconstructed, detached, frame kitchen. It is covered with a molded edge clapboard. It is in the center of a park and used as a museum.

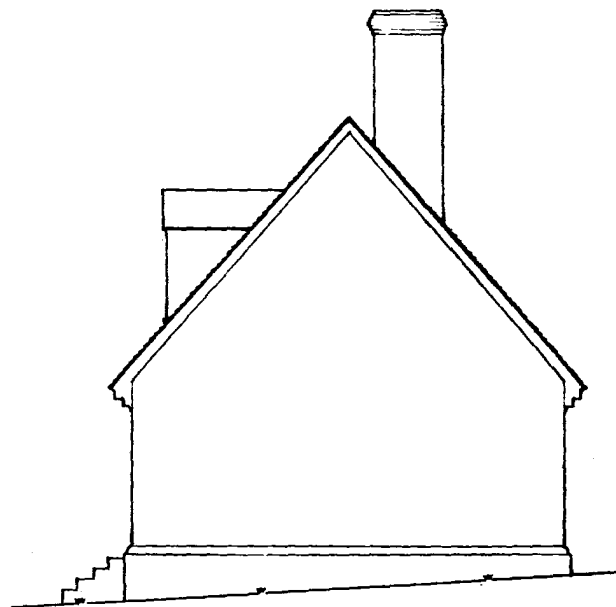

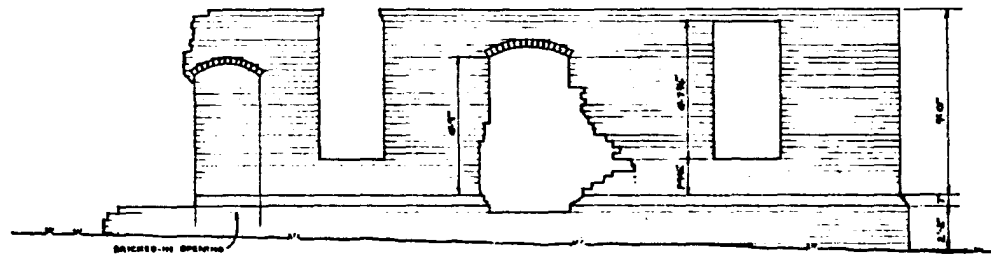

NEAR MARDURY, CHARLES COUNTY, MARYLAND



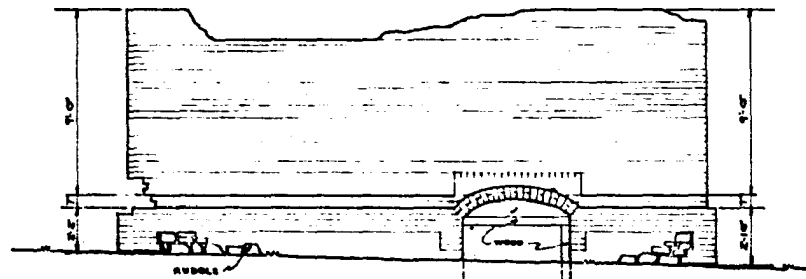

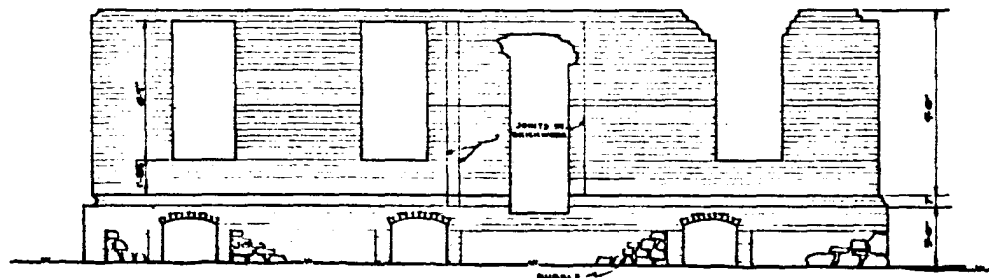


EAST ELEVATION

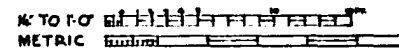
EAST ELEVATION

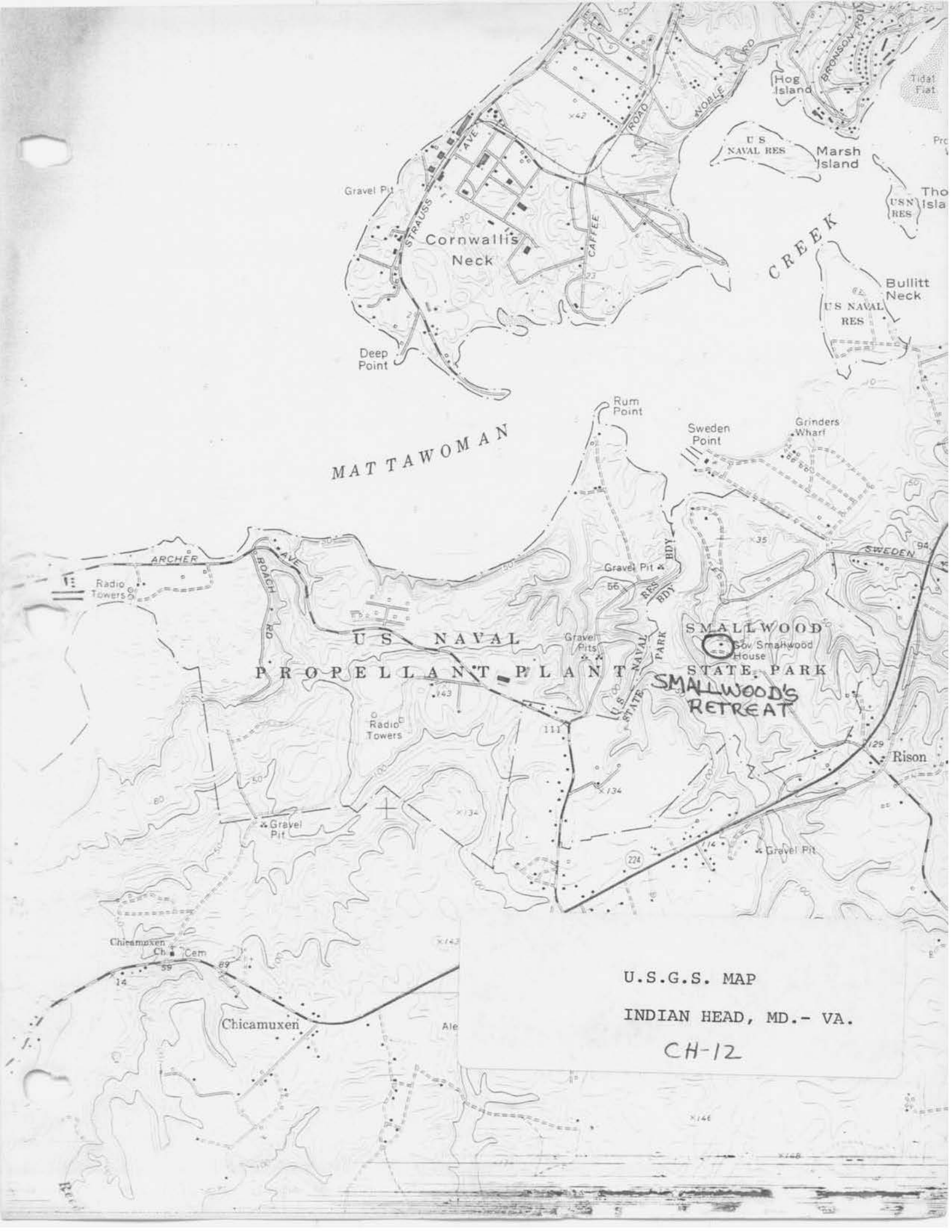

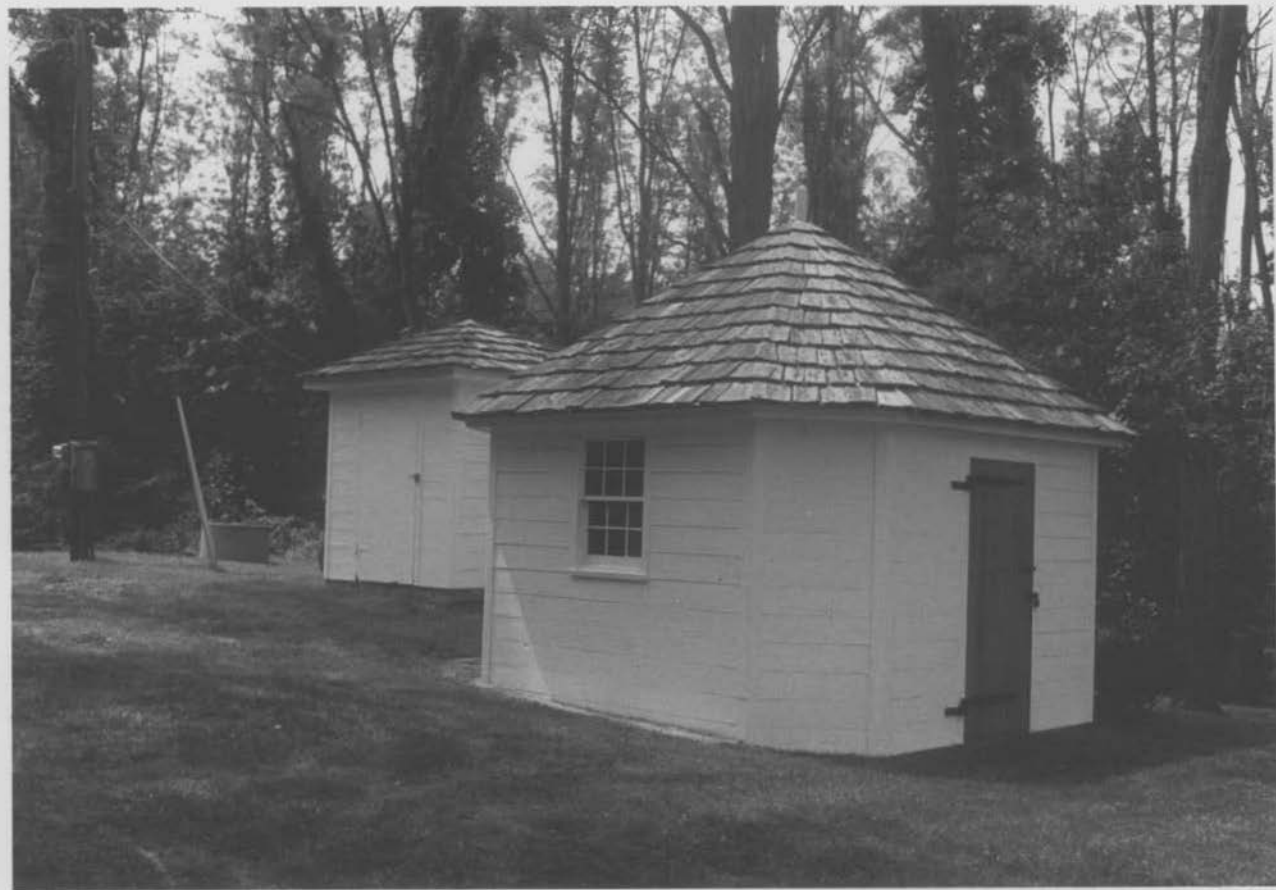
