Description Summary:

The Cockey/Jamison/Hendrickson House is a 2-1/2 story late Federal style frame house with a side passage plan, located in the village of Urbana in Frederick County, Maryland. Built ca. 1850, the house retains its early (not original) floors, as well as the original woodwork and mantel in the front parlor. A two story extension was added in the 20th century. This was the home of Sebastian Graff Cockey (1811-1888) who also ran a general store ("Cockey's Cash Store") on the property. The store, a separate building, operated until 1927, when it was rebuilt in rusticated concrete block with cast concrete quoins, and continued to operate as a general store serving the local community until 1958. Since that date, the building has served a variety of commercial uses. In 2005, the house was approved for use as offices.

General Description:

The Cockey/Jamison/Hendrickson House is an ell-shaped two-and-a-half story gable roofed frame building constructed circa 1850. It faces south, on the north side of Urbana Pike near the center of the village of Urbana, Maryland. It was constructed as a single family residence, detached from other structures but related to a store building to its southwest. The principal façade is three bays wide. The entrance is located in the rightmost bay, and holds a (replacement) 15-light glazed door surrounded by a five light transom and two four pane side lights with recessed paneling. Two 6/1 windows with plain trim and louvered shutters are located in the left and center front bays. A half hip roofed porch supported by Doric columns extends across the front of the building and a modern carport roof has been extended to the east of the original building. Three 6/6 windows with plain trim and louvered shutters are located in the three bays on the second level. The standing-seam metal roof on the front and ell sections is finished with a plain boxed cornice with return. Two single white-washed chimneys rise from the west end of the front section and center rear of the ell section. The house is built on a low rubble stone foundation.

The original part of the east side of the front section is two bays wide. A small window with shutters is found in the first bay on the second level, and one 6/6 window with louvered shutters is located in the second bay. Two small windows are located in the east gable end.

A two-story 20th century addition extends from the north side of the original building and along the east side of the service wing. This addition continues to the north in a one-story configuration adding one large room.

The west side of the building is four bays long, and a 1930's enclosed sun parch extends along the west side at the first level. Four wide modern 1/1 windows are located in the four bays on the second level, and the original louvered shutters have been removed. (Some of these shutters

are retained in storage.) The west gable end of the original building has two original small windows, and a modern side-by-side window with a roman arch fixed transom has been added between the small windows.

The interior of the ca. 1850 house is organized in a side-passage plan, with a stair hall running the full depth of the main block. Double parlors open off the hall. The dogleg stair rises against the exterior wall, and features walnut newels and handrail, square balusters, and molded step-ends. The hall doors are trimmed with symmetrical molding with a peaked central element and pyramidal-centered corner blocks. The inner architraves of the parlors have slightly different symmetrical molding and bulls-eye corner blocks. Original trim in the front parlor includes a fireplace with an arched opening framed by an Italianate-influenced mantel; this mantel is currently painted, but appears to be of slate construction, likely originally marbled. The rear parlor has a rectangular mantel with reeded pilasters, frieze, and brackets.

At about the same time as the house, ca. 1850, Samuel Graff Cockey constructed a dry goods store adjacent to the house on the southwest. This building was replaced in 1927 by the present one-story rusticated concrete block ("faux stone") building with an attic, built on a rubble stone foundation. The store faces south and is situated near the right-of-way of Urbana Pike. The façade of the store has the original large multi-pane glass display windows flanking a recessed doorway with a modern wood door and a single pane transom. Original floors from the 1927 rebuild also remain, as does the original decorative pressed metal ceiling. There are three five-light transom-type windows located high along both east and west sides of the building, and there are two modern windows located in the north end. The roof is covered with asphalt shingles and a matching canopy extends from the front of the building out to the street, reflecting the building's historic furnishing with gas pumps for automobiles. A flat-roofed rectangular extension on the west side is contemporaneous with the store and is constructed of the same materials. This extension is fitted with paired sash windows flanking a central door.

Both buildings retain a high level of integrity to represent their type, period, and method of construction. The series of minor additions to the house, and the application of vinyl siding, do not obscure its historic form as a representative example of the regionally-typical side passage plan form with service wing. The store building is essentially unchanged from its early 20th century construction, with its original storefront and rusticated concrete exterior walls fully intact, and significant interior details including wall finishes and pressed metal ceiling.

Summary Statement of Significance:

The Cockey/Jamison/Hendrickson House and Store property is significant under Criteria A and C in the areas of Commerce and Architecture. The property has been at the center of life in the village of Urbana since it was established by the scion of an old Maryland family around 1850. The property is significant under Criterion A for its association with a pattern of small-town commerce that characterized the rural area from the mid-19th century to the mid-20th century. The property has supported local commerce continuously since Samuel Cockey established a dry goods store on the site ca. 1850. Cockey's original store was replaced by the present building in 1927, and the present store continued in use as a dry goods, hardware and farm supply store, with Esso gas pumps out front, until 1958. The house also served as a tourist home in the World War II era.

The house and store are significant under Criterion C as representative examples of their architectural types which retain substantial integrity. The house reflects the regionally-traditional side passage, double pile plan with a service ell at the rear; the quality of its interior detailing offsets the effect of minor exterior alterations and vinyl siding. The store building remains largely as it was constructed in 1927, with an exceptional combination of rock-faced concrete block and rusticated quoins, intact original storefront, and interior finishes including a pressed-metal ceiling. The buildings stand out among the few reminders of Urbana's small-town past, as the village has largely been lost to extensive recent commercial and residential development.

The period of significance, ca. 1850-1958, begins with the construction date of the house and the establishment of a dry goods store on the site, and ends with the death of storekeeper George Otis Hendrickson, after which it no longer functioned as a general store serving the local community. Road realignments in the early 1950s began to divert traffic from the village, and subsequent intensive development has radically altered Urbana's historic identity as a local center of small-scale commerce.

The property derives local anecdotal interest from its reputed role as the site of General J. E. B. Stuart's cavalry encampment in September 1862, during which he and his officers held an impromptu fancy dress ball for the local ladies at the large building next door called Landon, a former boys' military school sitting empty during the war. This event has been re-enacted in recent years as the "Sabers and Roses Ball."

Located near the center of the village of Urbana, at the intersection of two thoroughfares, Fingerboard Road and the Urbana Pike (Maryland Route 355, the historic Frederick/Georgetown Road), the house and store (among the half-dozen oldest buildings in Urbana today) were probably built circa 1850, soon after Sebastian Graff Cockey (1811-1888) of Baltimore purchased the land from Henry Nixdorff, a local land investor. Cockey operated a dry goods and hardware store in a small building near the house, selling nails, shoes, cloth and farm supplies.

Cockey was a Southern sympathizer, which may have influenced General J. E. B. Stuart's choice of the Cockey grounds for his encampment in September 1862. It is reported that Stuart enjoyed the hospitality of the Cockeys. Visiting the Cockeys' daughter at that time was a relative from the North who became a friend of Stuart's, whom he called "the New York rebel."

One evening Stuart, with his officers and some ladies of the village, walked through the empty rooms of the abandoned military academy next door, the National Register property called Landon. On the spur of the moment, Stuart decided to give a ball in honor of his troops' arrival in Maryland. Invitations were sent to families for miles around, and the following evening the ball was enjoyed by all. During the evening shots were heard in the distance, to the south towards Hyattstown, and the troops rode off to engage the enemy. By 1:00 a.m. Stuart and his officers had returned and the band struck up again. Casualties from the night skirmish were brought in and the women left the dance floor to tend their wounds.

The New York Times of October 16, 1862 carries an article about the "Rebel Raid in Maryland" that reports on the local accounts of the Rebel visitation, and describes Sebastian Cockey as "a noted Secessionist, who was some time ago arrested at Williamsport, and having a son in the rebel army." There is also a report in *The Frederick Examiner* of August 31, 1864, that Sebastian G. Cockey, Urbana resident, was paroled after having been arrested and charged with "piloting rebels." Stuart's chief staff officer, Colonel Luke Tiernan Brien, one of the officers taking part in the ball, returned to Urbana after the war and purchased the Landon property, where he lived for a time.

Sebastian Graff Cockey was born on January 15, 1811 to William Cockey (1783-?) of Frederick County, Maryland and Catherine Graff (1788-?) of Pennsylvania. Sebastian married Elizabeth Sprigg on June 1, 1835. She was born on July 26, 1817 and died in 1890. They had seven children: Sebastian Sprigg Cockey (1837-1892), Catherine Cockey (1841), Ann Worthington Dorsey Cockey (1844), Elizabeth D. K. Cockey (1849), Otho Sprigg Cockey (1855), William A. Cockey (1858), and Bell Sprigg Cockey (1862). Sebastian died on August 20, 1888 and is buried in Mount Olivet cemetery in Frederick, Maryland. According to 1850 census data, S. G. Cockey owned two slaves, while the 1870 census lists one black domestic servant. The 1860

census includes the father, William, at age 78 as a member of the household, but he does not appear in the 1870 data. It should be noted that connections with several prominent Frederick County families, including the Spriggs and the Worthingtons, are represented in these family members.

Sebastian Cockey operated "Cockey's Cash Store" on the site until 1869, when he sold the house and store to John J. Jamison for \$2,500. Jamison continued to operate the dry goods store until 1907, when he sold the house and store to George Otis Hendrickson. Mr. Hendrickson was a prominent businessman in the village as a dry goods merchant. In 1927 he built a new store on the site of the old one, and continued in the dry goods business and retailing of gasoline (Amoco/Esso) until his death in 1958 while working in his store at age 83.

Since then, the store has operated in a variety of uses and today houses a hair styling salon. During World War II, the Hendrickson family rented out rooms in their residence, operating it as "The Cedars," a tourist home. It reverted to a private residence in the following decades. The current owner purchased the property in 2004 to save the historic house and adjoining store from demolition for the construction of new medical offices on the site.

The basic structures of the 1850 house and 1927 general store are intact today, with the same configurations of front facades, fenestration and projecting porches as shown in early 20th century photos. The residence has a rear kitchen addition that was probably added in the early 20th century, with bedrooms above. Today, all the rooms of the residence, on the ground floor and upper bedroom floors, are rented as office space to local service businesses (real estate, law, accounting, etc.)

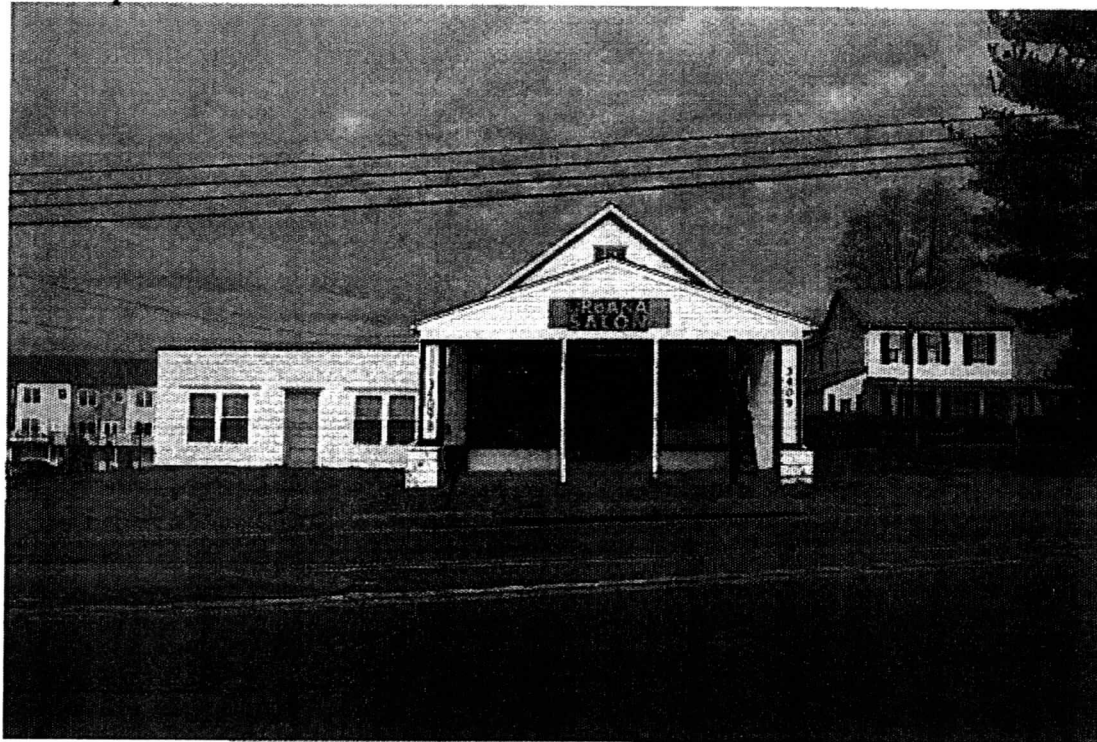

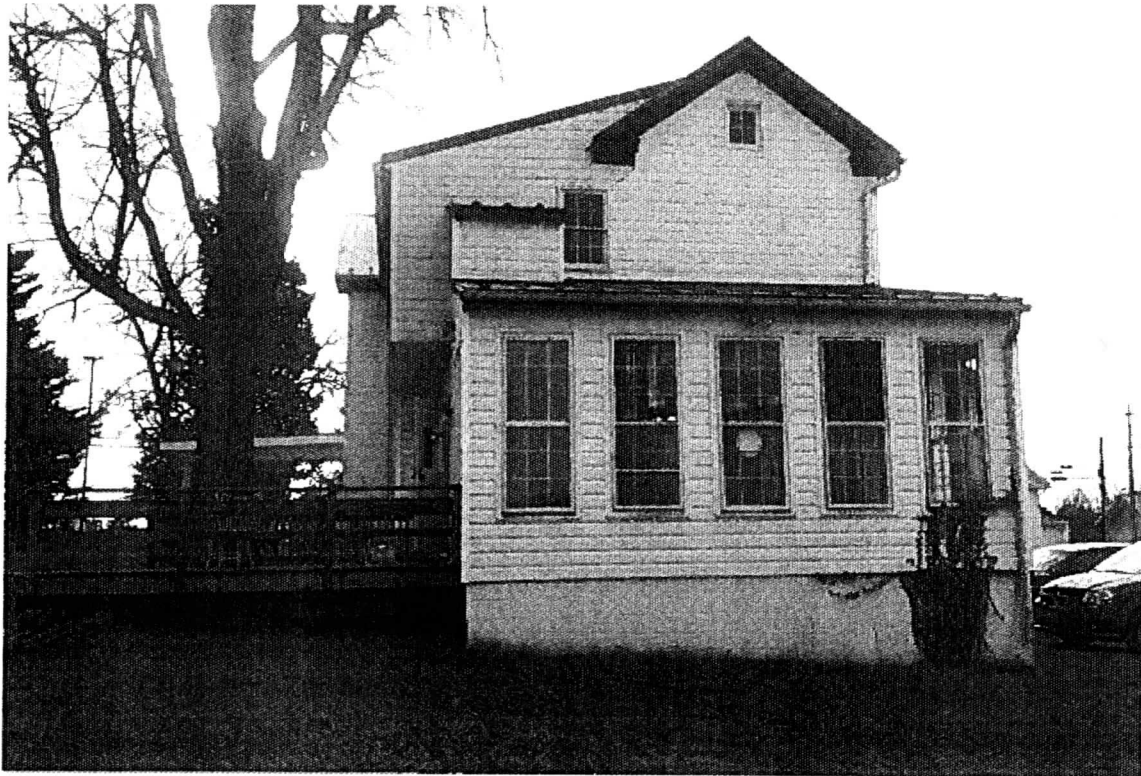

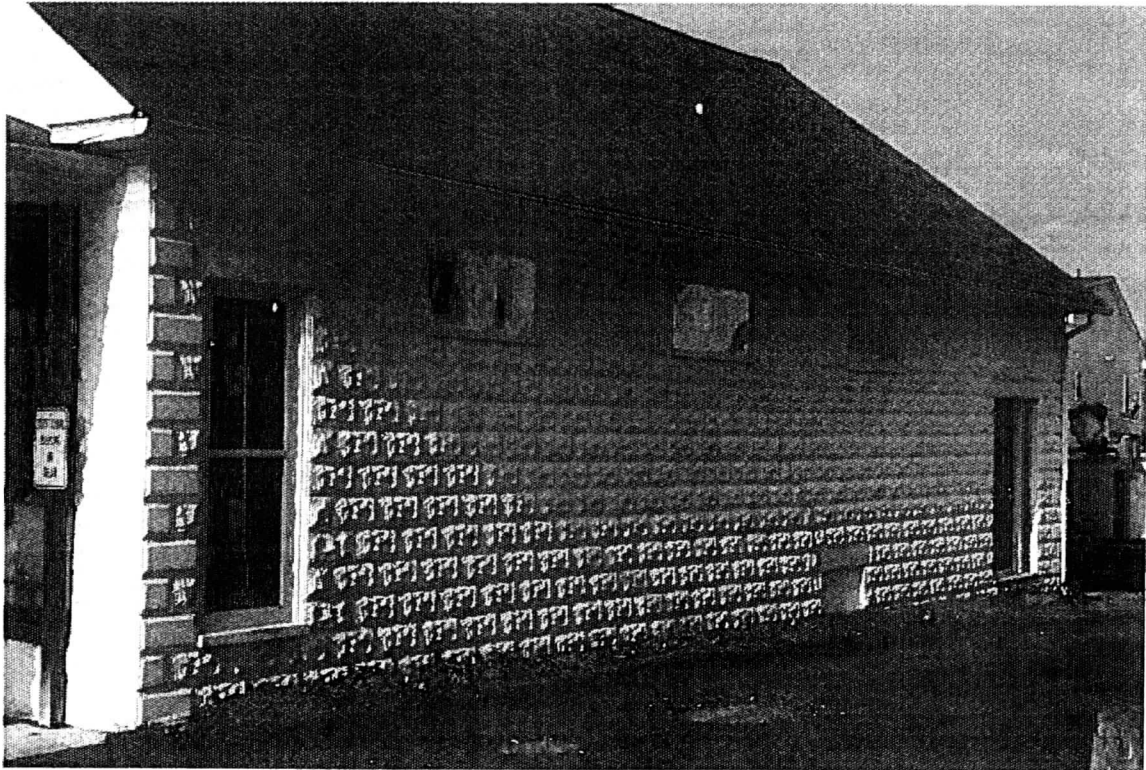

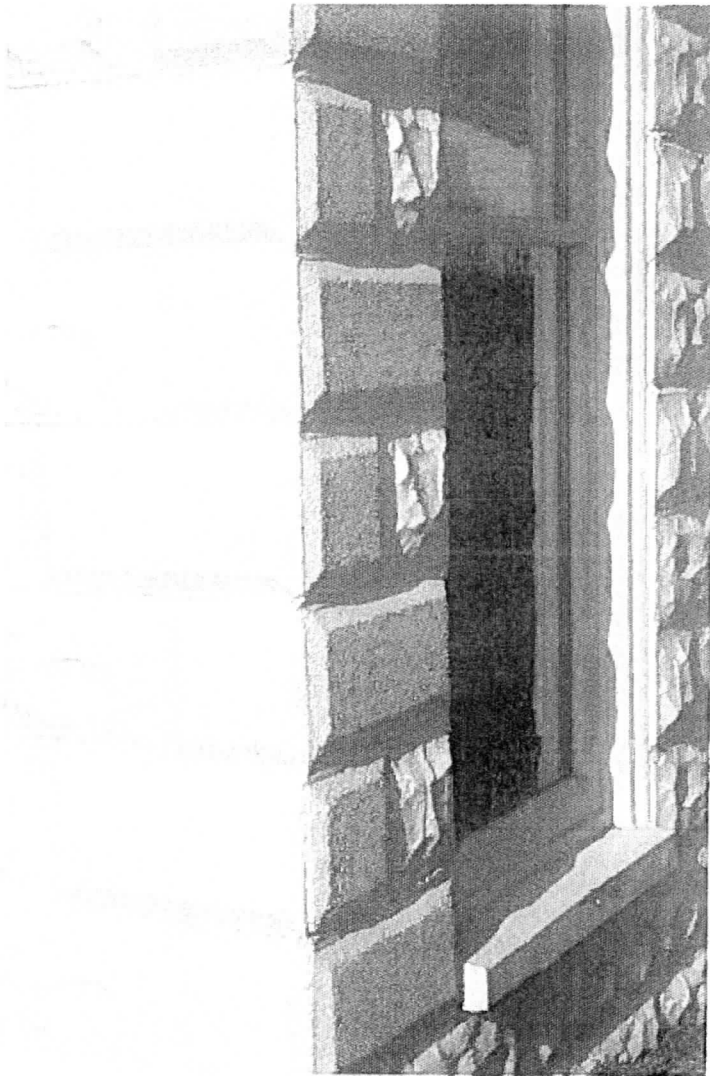

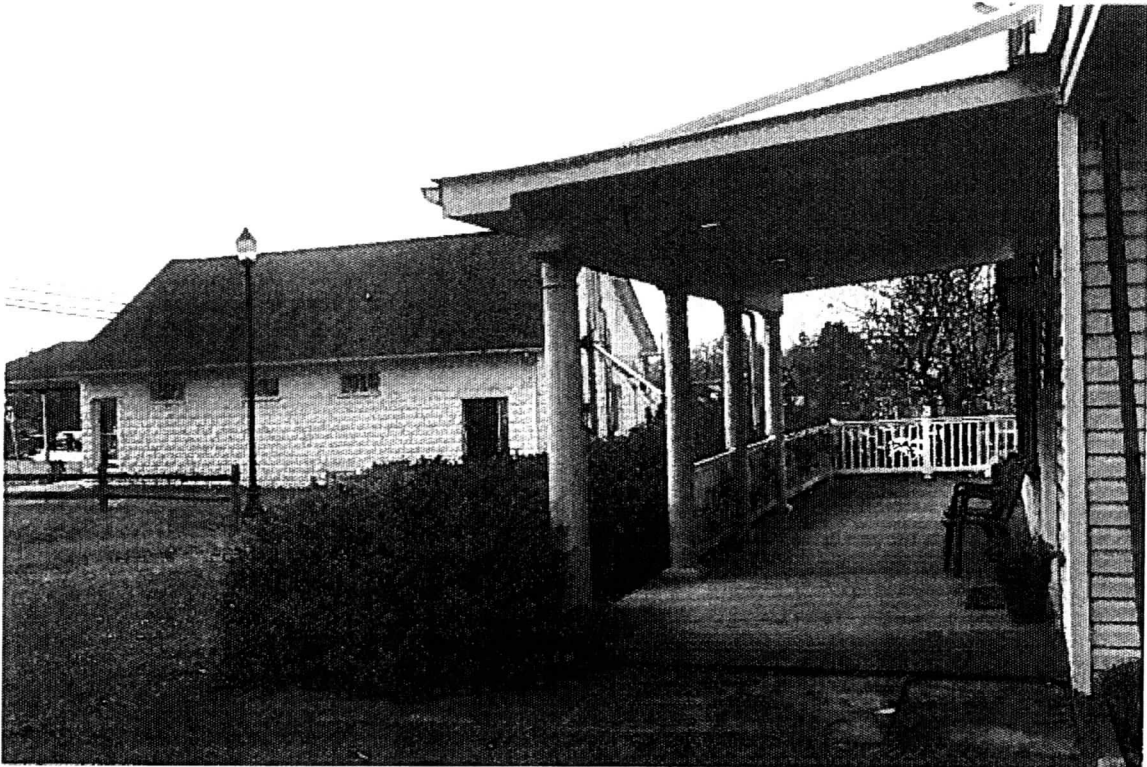

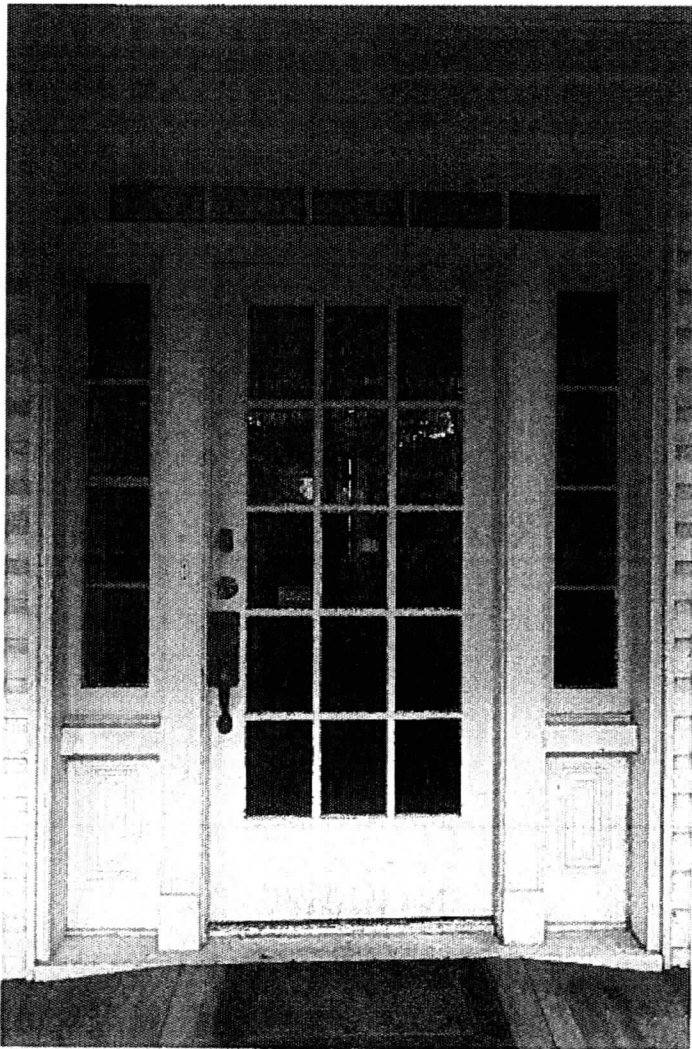

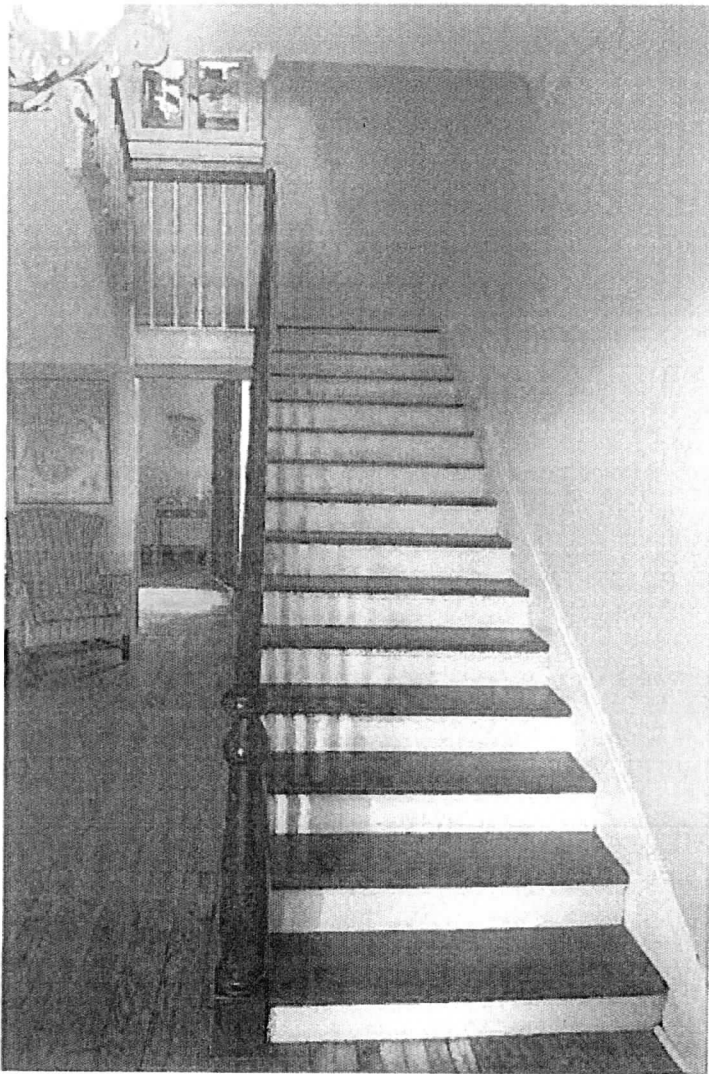

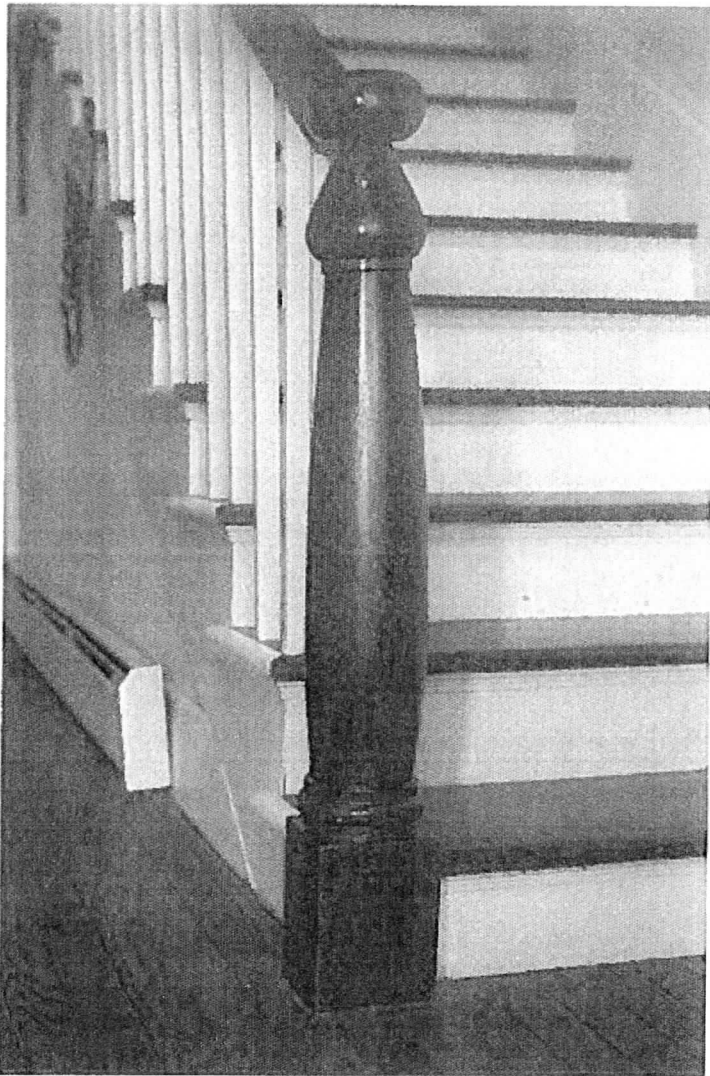

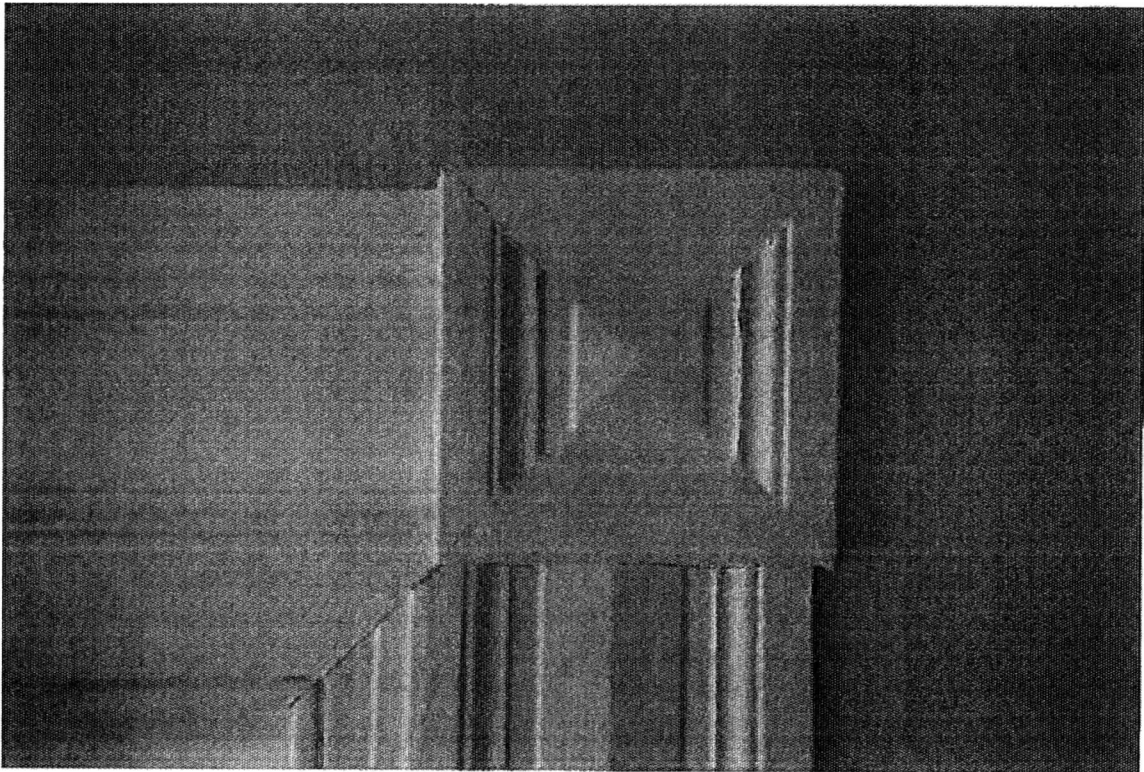

George O. Hendrickson,
Well-Known Urbana Mer-
chant, Dies Suddenly



George O. Hendrickson

George O. Hendrickson, who for over half a century had operated a general merchandise store in Urbana, dropped dead in the store Thursday morning. It was reported he was waiting on a customer and collapsed about 10:10 o'clock.

State Police and the county medical examiner were called. He resided with his wife and daughter and her husband and family, Mr. and Mrs. O. Wilson Runkles, in a house next to the store. Mr. Runkles is County Roads engineer. Mrs. Runkles is principal of Urbana School.

Mr. Hendrickson, aged 83, was a son of the late Ephraim and Ceelia Anderson Hendrickson and was a member of St. Ignatius Loyola Catholic church, Urbana.

He was a contractor and builder for a number of years in Washington, D. C. and Montgomery County and for the past 31 years had operated a general merchandise store at Urbana. He was a former member of the Save-U Store Association.

Surviving are his widow, Mrs. Pearl Watkins Hendrickson, three children, Mrs. Lucille Plassnig, Baltimore; Mrs. Runkles and George O. Hendrickson Jr., Salisbury. Five grandchildren also survive. He was the last member of his immediate family.

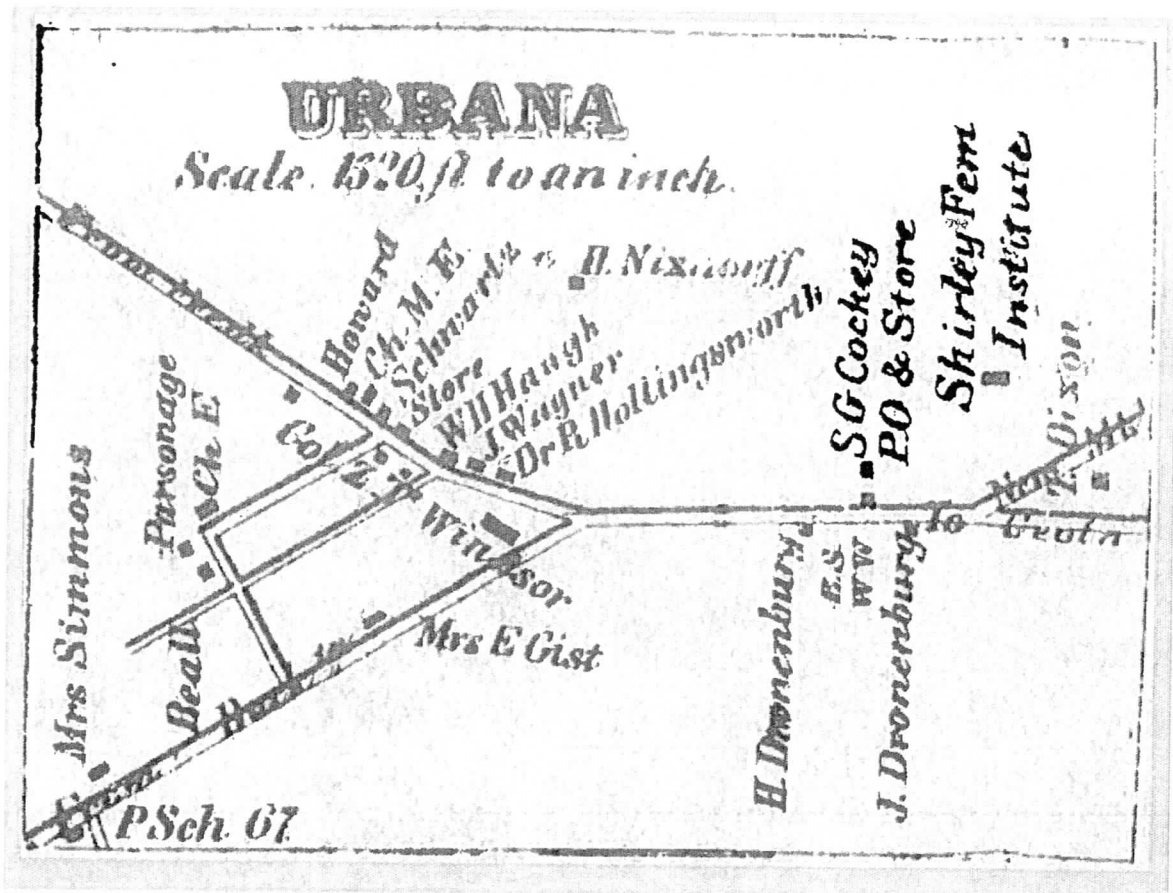

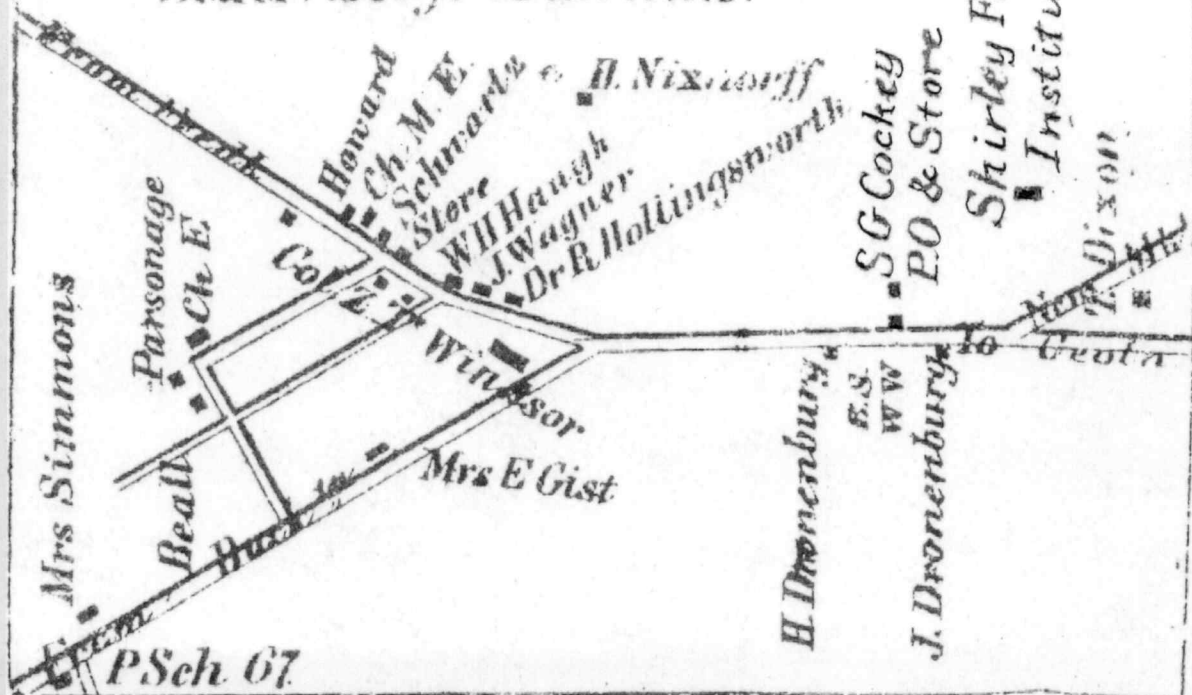
