Summary Description:

The RCG&A Arundel Mills Site 2, or 18AN1120, is a small prehistoric lithic scatter located in the Arundel Mills area of Anne Arundel County, Maryland. The site is situated on an upland ridge top about 120 m from an intermittent stream that flows into Piny Run Creek. Piny Run Creek flows into Deep Run, which eventually empties into the Patapsco River. The site is approximately 20 X 40 m in size. Prehistoric forest cover is thought to have consisted primarily of oak, sweetgum, and yellow poplar. Soils at the site are Bibb silt loam and Sassafras fine sandy loams and loam.

The site was first identified during a Phase I survey for the (then) proposed Arundel Mills Development Project in Anne Arundel County, Maryland. The development project entailed the construction of a large shopping mall facility on a 400 acre parcel and related developments on two additional smaller out parcels. The out parcels include an access road from the Baltimore-Washington Parkway and an interchange at the parkway, which is off-site. During this study, shovel testing was done on a 20 m grid with additional testing around artifact bearing shovel tests at a 10 m interval. Six shovel test pits (STPs) contained prehistoric cultural material.

The Phase I assemblage collected in 1998 included 12 flakes, 8 pieces of shatter, and 2 fragments of fire-cracked rock. Though a generally undifferentiated lithic scatter, a significant number of artifacts were recovered from the B horizon. Based on these findings, the site was recommended for Phase II testing if it could not be avoided.

This Phase II testing was conducted at the site in January of 1999. Additional STPs were excavated at a 5 m interval to gather additional information about artifact distribution and spatial patterning across the site. All STPs were hand excavated and measured approximately 35 cm in diameter. STPs were excavated by natural strata to a depth of 40 cm below surface or 10 cm into sterile subsoil, whichever occurred first. All soils were screened through hardware cloth.

All told, 45 STPs were excavated at 18AN1120. Phase II test resulted in the recovery of an additional 6 pieces of quartz debitage. These included 2 primary flakes, 2 secondary flakes, and 2 pieces of shatter. No features were encountered in any of the STPs. Based on the paucity of data recovered, no test units were excavated at 18AN1120 as would be typical in a Phase II project.

In total Phase I and Phase II testing produced 21 artifacts. The artifact assemblage from Site 18AN1120 suggests that the area was used as a limited lithic procurement site. It appears that there is a limited amount of primary reduction being done on the quartz cobbles occurring naturally at the site, although debitage weight and quantity is fairly low for a primary lithic reduction site. There was a small concentration of artifacts in the center of the site, with a lighter scatter extending to the southeast. The fire cracked rock was found within the main concentration. All but one of the artifacts were found in the B horizon at depth between 10 to 48 cm below surface. One artifact was found within the Ao horizon. No tools or diagnostic artifacts were recovered from the site. Again, no features were identified.

18AN1120 appeared to have undisturbed soils deposits. However, due to the topography, soil stratigraphy, and vegetative signature of the site, it is likely that the soil column observed during these investigations is the result of artificial deflation causing an apparent absence of the A Horizon. Research potential at 18AN1120 is limited due to the low density of artifacts, and lack of temporally diagnostic artifacts. An analysis of the type of debitage recovered from the site indicates that the site was a limited use lithic procurement area. Little more additional information could be provided by further research at the site.
