## Summary Description:

The Lake Site, 18AN238, is the remains of a lithic scatter with a possible Early Woodland component west of Glen Bernie in Anne Arundel County. The site is situated on a stony terrace overlooking Stony Run and adjacent to an unnamed artificial lake. During the period of its investigation, the site was grown up in secondary vegetation, predominantly Virginia pine. Prehistorically, this area was likely populated with indigenous scrub hardwoods. Soils at the site are typical of the Evesboro-Urban land complex.

The site was first identified in 1975 by an Amateur Archeologist, Dennis Webb. Webb reported finding projectile points and debitage on the surface of the site. Only three of the artifacts (projectile points) collected by Webb have ever been documented. One is a Piscataway point and another is a Periwinkle point. The third point is a damaged and heavily reworked point which can't be assigned to a type.

The next documented archeological work at the site was carried out in 1977. At that time, a Phase I reconnaissance survey was carried out of the (then) proposed right-of-way (ROW) for the extension of Maryland Route 100 from MD 3 to I-95 in Howard and Anne Arundel Counties. The ROW was approximately 8 miles in length and 91.44 m (300 ft) wide. The work was conducted to comply with federal and state laws such as the NHPA. The study area was traversed by car and examined from different viewpoints, with high potential areas examined on foot. High potential areas included 1) previously recorded sites, 2) exposed surfaces such as plowed fields, tree falls, and erosion cuts, and 3) areas ecologically favorable for site location but covered with vegetation. In addition, STPs were dug in areas considered very favorable for site location in an attempt to locate any buried archeological remains or features that may be present.

Since 18AN238 was already a reported archeological site, it was surface collected during the 1977 survey. One quartz trianguloid point and two quartz flakes were recovered from the surface, but all 3 artifacts appeared to have been either relocated or redeposited. It was noted in 1977 that the area had been extensively disturbed by gravel operations and it appeared that the occupation levels of the site were no longer extant.

The lake site was not examined again until 1982. This study was conducted by members of the Potomac River Archeology Survey, when they received authorization from a development corporation to test the site, which would be destroyed by proposed construction. It was essentially a salvage operation.

Prior to initiating formal investigations, the researchers visited the site with Dennis Webb, the amateur archeologist responsible for identifying and initially reporting 18AN238. It was immediately apparent that the site had suffered extensive disturbance including depauperage and power grading on a massive scale. Two subsequent visits were made by the Potomac River Survey researchers to assess the damage and ultimately, it was determined that the entire site had been completely destroyed.

In addition to visual inspection of exposures, shovel testing was used to assess the damage in vegetated areas. A single possible artifact was recovered, a quartz uniface, from the lake margin. Though undoubtedly mechanically modified, the morphology displayed by the piece is often fortuitously duplicated when quartz is accidentally fractured by heavy equipment. Otherwise, the site simply showed extensive evidence of surface modifications. Most of this destruction was caused by gravel mining near the site with heavy equipment. Ironically, the creation of the "lake" for which the site is named (actually a flooded former sand and gravel pit) is the very thing that led to much of its destruction.

The 1982 work at 18AN238 definitively shows that the site has been destroyed. It is not a significant archeological resource.
