## Summary Description:

Site 18MO357 is an apparent lithic scatter of unknown prehistoric affiliation located in Germantown, Montgomery County, Maryland. The site is also known as South Germantown Recreational Park #2. The land on which the site sits was largely devoted to agriculture with some forested land mixed in until modern times. The land is part of the Potomac River drainage. Soils at the site consist of Manor silt loam and Glenelg silt loam.

The site was first encountered in 1991 by an archeologist working for the Maryland National Capital Parks and Planning Commission (MNCPPC). At that time, the site was reported to be a "sparse" scatter of lithic materials near a gully in an agricultural field. No fieldwork was conducted at that time. Fieldwork was first conducted at the site in 1995, when a Phase I/II project was conducted at the site. At that time, a proposed residential subdivision called Kingsview Village was planned for the Old Germantown area that includes Site 18MO357 along with several historic structures (houses and barns). In order to proceed with development, an Army Corps of Engineers wetland permit was required. Issuance of this permit enacted the National Historic Preservation Act of 1966 and triggered the Phase I and Phase II work. All of the historic structures examined were determined to be historically insignificant, and since 18MO357 was already a documented site it was determined to proceed directly to combine Phase I and II work into the same project. Work was proposed in two phases. A shovel test survey would be conducted to determine site boundaries. These shovel tests were to be placed on a 7.62 meter (25 ft) grid across the site. Once the site boundaries were identified, excavation units were to be dug to better document soil profiles to determine site integrity. These would be placed in the areas most likely to contain buried deposits, significant artifacts, or features, as determined by the shovel test results.

Archeological site 18MO357 essentially could not be located. The location, as recorded by MHT was visited and the MNCPPC archeologist also revisited the site with project personnel. The location denoted by MHT was on one side of an erosional gully in an active wheat field, while the location denoted by the MNCPPC archeologist was on the other. As a result, both locations were subjects to shovel testing. A total of 18 shovel tests were excavated, resulting in the recovery of not a single artifact. Soil profiles were uncomplicated with plowzone resting on bedrock. Because no artifacts could be found, the excavation units were not dug. In the absence of any detectable deposits, it has been determined that Site 18MO357 is not a significant prehistoric resource.
