## Summary Description:

Site 18PR52 (also known as the Parking Lot site or College Park Site III) is an apparent prehistoric short-term resource procurement site on the University of Maryland College Park Campus in Prince George's County, Maryland. The site is situated on a low terrace adjacent to a tributary of Paint Branch. At the time of archeological testing, the area included a soccer field, a grassy area between the soccer field and tennis courts to the west, and sidewalks and the bank of the tributary located south of the soccer field. Soils in the area of 18PR52 are mapped as luka silt loam along the creek, and a complex interdigitation of Keyport silt loam and Sassafras gravelly sandy loam away from the creek.

According to MHT files, the site was first identified during a survey of the campus by University of Maryland Anthropology faculty. A salvage survey was then performed on the southern portion of the site in 1971. This portion of the site was being impacted by the extension of a parking lot at that time. Where impacted, the site was destroyed. All topsoil was stripped away for use elsewhere on the University of Maryland property (eventually it would be replaced by fill). When all the topsoil was removed, plow scars were visible in places. However, no prehistoric features were identified. A grid was laid out over the affected portion of the site and a controlled surface collection was conducted in 1.524 meter (5 ft) square collection plots. In some areas, surface collection was done as a simple walkover survey, with grid positions merely estimated.

At least 300 flakes were recovered from the site, as well as 12 projectile points and 2 prehistoric ceramic sherds. Preliminary analysis of the collection identified the site as a "hunting camp" dating from the Archaic and Late Woodland periods (though no description of diagnostics is provided in field notes in MHT site files). The Late Woodland material was concentrated in the lower lying portion of the site, while Archaic material was found across the whole site.

Archeological attention was again paid to the site in 2000, when the University of Maryland began making plans for the construction of their new Comcast Center indoor stadium/arena facility. Because Phase I work had already conducted, a Phase II-level testing was planned from the outset. However, the initial stages of the Phase II work clearly documented that the area was highly disturbed (see below). As a result, the Phase II fieldwork conducted at 18PR52 is more akin to what would normally be considered a Phase I survey.

Twenty-six shovel test pits (STPs) were excavated across the remaining portion of 18PR52. Testing between the tennis courts and soccer field was limited to the eastern edge for the area since manholes down the center of the strip indicated that this was a major utility conduit. Otherwise, shovel tests were excavated at 10 m intervals. Shovel tests measured approximately 30 cm in diameter. All soils were excavated in natural (or cultural) stratigraphic levels and were screened through hardware mesh.

The Phase II STP survey revealed extensive evidence of soil disturbance. The most likely explanation for the soil profiles encountered is extensive modification by modern construction activity. It was evident that extensive grading had removed much of the original topsoil in this area. No artifacts were recovered from the shovel tests excavated here. As a result, Site 18PR52 clearly lacks integrity and should not be considered a significant archeological resource.
