Summary Description:

The Country Lakes Site (18ST415) is a prehistoric short-term camp, possibly a lithic quarry and reduction site. The site is located along a small wooded terrace above an unnamed tributary of Chapito Creek, in St. Mary's County, Maryland. Chaptico Creek lies to the west and Hayden Run lies to the east of the site. The soils in the area are of the Beltsville-Croom-Sassafras association. The site boundaries roughly measure 42 m x 117 m.

In May 1982, a Phase I investigation was undertaken to assess the archeological resources along an 11 mile right-of-way (ROW) of the Southern Maryland Electric Cooperative proposed Ryceville to Loveville transmission line, from Charles County to St. Mary's County, Maryland. The majority of the ROW is in St. Mary's County. The goals of the project were to locate archeological sites and obtain basic information concerning site age, function, depth of deposits, and horizontal extent where possible, and to make recommendations for construction. Field methods included the excavation of shovel test pits and/or surface collection. During the surface collection, only a representative sample of the various categories of artifacts present was collected, rather than attempting to collect everything encountered. The ROW was divided into 8 parcels, each parcel roughly corresponding to discrete drainages and/or geographic areas. During the survey, a total of 36 sites were identified, including 18ST415, which was located in the 'Chaptico Creek to Mechanicsville - Chapito Road' parcel.

18ST415 was located by the excavation of 4 shovel test pits (STPs). The site was defined by the contents of 3 of the 4 STPs. Artifacts including decortification flakes, along with finds of hammerstones, demonstrated that quarrying and reduction activities were reflected at the site. In addition to the STPs, a few items were collected from the surface, in the site area near the adjacent stream bed.

The 22 prehistoric artifacts collected during the Phase I included 7 quartz flakes, 5 quartzite flakes, and 4 flaked cobbles (2 quartz, 2 quartzite). There was 1 tool, a quartz biface fragment. There were 3 fire-cracked rocks. Other lithics included 2 hammerstones.

A Phase II investigation at the site was undertaken in May of 1983. The main goal of the study was to determine what information the site could contribute to an understanding of Maryland prehistory and history. Investigations involved archival research, which revealed nothing about the land parcel, excavation of 23 STPs at 1.524 m (5') intervals, and the excavation of one 1 m² test unit (Unit E) in the area of the only positive STP (N15) and a second test unit (Unit F) closest to the positive STPs from the Phase I study. A datum was established 0.914 m (3') west of stake 165. All excavated material was screened through ¼" mesh and all artifacts were retained.

Only 2 artifacts were collected during the Phase II survey, 1 quartzite flake and 1 possible quartzite tool.

While the Country Lakes Site (18ST415) possibly represents a prehistoric quarrying and reduction site, the lack of diagnostic material impedes assessment of the duration and variation of prehistoric utilization of the site. Additional study would not further enhance the understanding of the full range of activities that may have been carried out within the site area. 18ST415 can contribute little to the understanding of utilization of upland sites in Southern Maryland. No further work was recommended at the site and the transmission line was given clearance to proceed as planned without additional archeological testing or data recovery prior to construction.
