Phase I	<input checked="" type="checkbox"/>	Project Justification: This report describes the findings of a 1991-1993 Maryland Maritime Archeology Program (MMAP) investigation at the Stephen Steward Shipyard on the West River in Anne Arundel County, Maryland. The work consisted of both terrestrial and marine archeological excavations. The project was a collaboration between MMAP/MHT personnel, the West/Rhodes River Consortium, and volunteers from the Archeological Society of Maryland (ASM). The site was threatened by impending development of a recreational parcel. The work began with simple reconnaissance and progressed to extensive excavations by 1993, when the ASM held their annual Field Sessions in Maryland Archeology at the site.

Phase I		Project Justification: This preliminary report summarizes the 1993 Field Session of the Archeological Society of Maryland (ASM), held in May at the site of the Stephen Steward's 18th century shipyard (18AN817). The project was carried out in conjunction with the Maryland Historical Trust, and the field work was undertaken by crews working both on land and in the water. During discussion with the property owners, concerns were raised over the potential disturbance of the site by development. Subsequent discussions with the Anne Arundel County Office of Planning and Zoning, as well as with other departments within the Maryland Historical Trust, revealed that the western portion of the site was protected from disturbance by an easement held by the Trust. The eastern portion of the site was also under an easement, but provisions of the agreement permitted future construction of certain specific recreational facilities on the apparent site of the shipyard. The obvious historical importance of the site, combined with testing which suggested the presence of intact remains, made it imperative that

Norman's Retreat (AA-228) is a 25 acre tract located within the original shipyard tract on which the Maryland Historical Trust currently holds an easement.

MHT holds an historical easement on Lot 2 and the homeowners' association was planning the installation of a paved path from a local road to a pavilion and an unpaved path from the pavilion to a nearby crabbing pier. The impact area was surveyed as a precondition for development on the easement lot.
